The Towns of Wheaton and Union, City of Eau Claire, and Chippewa and Eau Claire Counties are holding a Public Involvement Meeting for official mapping of County Highway T (CTH T) from State Highway 312 (STH 312) to State Highway 29 (STH 29). A map of the project location is attached.

An official map shows the locations of planned future public lands and facilities such as streets, trails, parks, and open space. As new development continues to be constructed and traffic continues to increase along this corridor, the above-mentioned communities and two counties are planning for a possible increase in the number of travel lanes.

This letter is to inform you that a public meeting regarding the official mapping process will happen on Monday, September 20<sup>th</sup> at 29 Pines / Sleep Inn & Suites Conference Center located at 5872 33<sup>rd</sup> Ave, Eau Claire, WI 54703.

A presentation of alternatives will be held from 4pm-5pm and an open forum meeting for all interested individuals will be held from 5 pm-6:30 pm. At these meetings, two possible design alternatives will be presented. There will be opportunities for verbal and written comments regarding both alternatives. Representatives from the above-mentioned communities and counties will be present at the meeting, along with the consultant working on this project.

The 4:00 pm – 5:00 pm portion of this meeting will also be held virtually.
