LOCAL GOVERNMENT CHANGES

This fall brought some unexpected changes to the Town of Wheaton local government.

1. Bob Sworski is the new Town Chair appointed to fill out the remainder of Steve Harmon’s Town Chair term.
2. Alice Droske is the new Town Vice Chair. In order to improve operational continuity and for the betterment of the Town of Wheaton local government a Town Vice Chair was established to fill in if a vacancy occurs with Town Chair. The Town Vice Chair is selected from the existing Town Supervisors.
3. Carolyn Kaiser is a new Town Supervisor appointed to fill out the remainder of Bob Sworski’s town supervisor term.

TOWN GOVERNMENT

The Town of Wheaton currently has three commissions (Plan Commission, Parks Commission, and Fire Commission) and from time to time can create specific citizen committees to research and analyze more strategic long term town initiatives. One important part of our commissions and committees is citizen involvement and so we are always looking for residents/property owners that want to be involved in local government.

The Plan Commission assists in the development and updating of ordinances, conditional use permits, and Town of Wheaton comprehensive plan. The Plan Commission consists of seven members: Dale Hayden (Chair), Tom Piercy (Vice Chair), Sara Hinz, Jessi Jones, Ron Kragness, Mike McGinley, and Mary Rudd (Town Board Representative). Secretary and Deputy Secretary to be set at the next meeting. The term for each member is 3 years, from May 1 to April 30. Appointment to the commission is by the Town Chair, with board approval. Terms are staggered. Two members one year, two members the second year, and three members changed the third year, maintaining a consistency in the commission. If you are interested in an appointment to the Plan Commission, please contact any Town Supervisor, Chair, or Clerk to add your name to the list. Meetings are normally once per month, on the first Tuesday, held at the Wheaton Town Hall at 7:00 pm.

The Parks Commission aids in the development and maintenance of Wheaton Park (63 acres) and boat landing in the township. The Parks Commission consists of seven members: Ken Books (Chair), Jenny Schutte (Vice Chair), Jan Dole (Secretary/Treasurer), Becky McInnis (Deputy Secretary/Treasurer), Cesar Arauz, Mark Kohls, and Aaron VanHove. The term for each member is 7 years, from July to June. Appointment to the commission is by the Town Chair, with board approval. The terms are staggered each year, with one member’s term expiring each year. If you are interested in an appointment to the Parks Commission, please contact any Town

Supervisor, Chair, or Clerk to add your name to the list. Seven years is a long commitment. Some members may not be able to stay that long, which means appointments may be more often than once per year. Meetings are once per month, on the fourth Tuesday held at 7:00 pm.

The Fire Commission consists of three members: Mark Brunner (Chair), Dale Hayden, and Steve Dybvik. The terms are for 3 years and staggered each year, with one member’s term expiring each year. Appointment to the commission is by the Town Chair, with board approval. The Fire Commission meets quarterly, with additional meetings when necessary. The main purposes of the Fire Commission are to review procedures of Wheaton Fire & Rescue, conduct disciplinary hearings for Fire personnel, and ensure the Department is serving the citizens and visitors of Wheaton Township as effectively as possible. If you are interested in an appointment to the Fire Commission, please contact any Town Supervisor, Chair, or Clerk to add your name to the list.

Commissions and committees are just one part of town government then there are all the parts of town government functions and issue resolution. To help residents and businesses with government functions and issue resolution the town board put together the below areas of focus listing that shows both primary and backup contacts for each area. 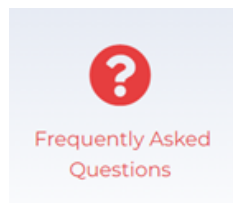


WEBSITE

ELECTION

NOTICE IS HEREBY GIVEN that the Spring Election for the Town of Wheaton will be held on Tuesday, April 2, 2024 from 7:00am to 8:00pm, the following officers are to be elected:

A TOWN SUPERVISOR, for a term of two years to succeed the term of Alice Droske, which will expire on the 16th day of April, 2024.

A TOWN SUPERVISOR, for a term of two years to succeed the term of Mary Rudd, which will expire on the 16th day of April, 2024.

NOTICE IS FURTHER GIVEN that the first day to circulate nomination papers is December 1, 2023, and the final day for filing nomination papers is 5:00 p.m. on Tuesday, January 2, 2024. Contact the Town Clerk for nomination papers, or obtain them from the following website: <https://elections.wi.gov/forms>. You will need EL-169, Nomination Papers, EL-162 Declaration of Candidacy (properly notarized), filled out and returned. Check state statutes for requirements if there is financing of your campaign. A minimum of 20 and maximum of 100 qualified electors must sign the nomination papers with legible writing. Please read the instructions with that form.

NOTICE IS FURTHER GIVEN, that if a primary is necessary, the primary will be held on Tuesday, February 20, 2024.

Acceptable Photo ID will be required to vote at this election. If you do not have a photo ID you may obtain a free ID for voting from the Division of Motor Vehicles.

ROADS

With 83 miles of township roads, which is more roads to maintain than most rural townships in the state, and being 100% paved there are certainly challenges. Road replacement costs for 1 mile are \$200,000+ and we need to get 40-80 years out of existing roads based on current funding levels. We continue to pursue ways of prolonging road lifecycles along with pavement and ditch maintenance to maximize the number of improvements to the roads for the available funds. Part of the long term solution will be continued road chip seal and crack patching cycles in order to extend road lifecycles. Plus there are several other ideas being discussed and tested before just turning to a tax levy increase. Plans are already in motion for 2024 road work.

FIRE DEPARTMENT

We presently have 30 volunteers on the roster. We would like to have closer to 40 volunteers actively participating in this rewarding activity. Most calls are for things other than structure fires. Off road rescues, car crashes, snowmobile incidents, downed power lines, searches, water incidents, and brush fires are just a few of the things dealt with. Medical first responding is the largest part of the fire department responses, with transport ambulances and paramedics coming from Eau Claire or Chippewa Falls. Call the fire station or contact any member of the fire department for more information. Training is provided!

The department is a paid-per-call, all-volunteer department. The fire station is at 3900 38th St, Elk Mound and is within the Wheaton Park. It is not a manned station. If you have an emergency, **dial 911 to contact the County Dispatch center**. They page out the firefighters as needed. For non-emergency calls, only, you can dial 715-874-6597 and leave a message. A return call or action will be made as soon as possible. You may also send a message to the department through Facebook.

BURNING PERMITS

Burning permits are not required in Wheaton, but you can only burn what is allowed by state law. Visit the Wisconsin DNR website at <https://dnr.wi.gov/topic/openburning/> for burning regulations and several fine articles about the alternatives to burning.

1. and click on Chippewa County.
2. Drive past Wheaton Park / Wheaton Fire & Rescue frontage road sign along Wisconsin 29 South Frontage Road. This is checked and maintained daily.
3. Follow Wheaton Fire & Rescue on Facebook.

If you burn, please be careful. You are responsible for all costs of extinguishing a fire that you started if it has gotten out of control. Burn only when sufficient moisture exists (rain and/or snow cover) in the area, winds are light (under about 7 mph maximum gusts), and temperatures are cool.



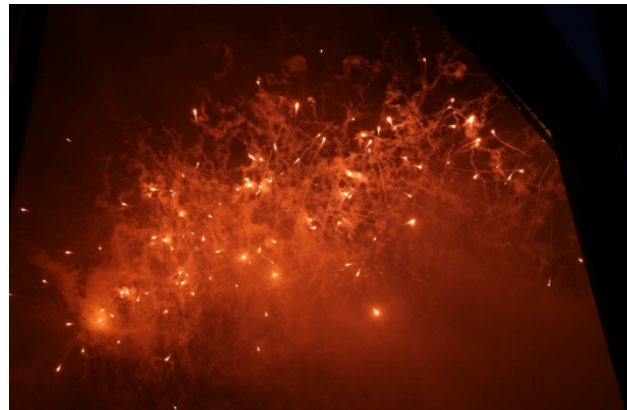

CLEAN GROUNDWATER

Groundwater provides drinking water entirely or in part for as much as 50% of the global population and accounts for 43% of all water used for irrigation. The Town of Wheaton continues to work in support of clean drinking water for all residents. It is important to note that the threat to clean water is lawn fertilizers, septic systems, and agriculture fertilizers and waste. Septic systems are not designed to filter out nitrates. They are designed to break down bacteria.

The Town of Wheaton has sponsored a Well Sampling Project since 2019. This has been offered to residents every year except 2020 during the pandemic. Results from the four years of testing provide baseline information that will help in the following ways:

- Assists the Township, Chippewa County, and U.W. Stevens Point Central Wisconsin Groundwater Center with documenting the current and changing conditions of groundwater in order to provide education, public information, applied research, and technical assistance in addressing groundwater issues.
- Helps residents monitor their wells for changes in groundwater so actions can be taken if needed.
- Provides information to other Chippewa County government and UW agencies on how soils, well depths, and changes in land use practices affect groundwater.

Continued and expanded residents testing has shown the Town of Wheaton has high nitrate areas. Boiling water will not reduce nitrate levels. In fact, it could make the level of nitrate slightly higher because some of the water will evaporate, however, the nitrate will remain. High levels of nitrates in water can affect everyone such as causing birth defects, blue baby syndrome, thyroid disease, and may increase the chance of colon cancer. High nitrate levels are 10 mg/L and higher.

We recommend annual testing of your water, as groundwater can change!

There are multiple ways to address nitrates in groundwater. Some can be quicker and more expensive while others could require more time and be less expensive. **There is no one solution that will solve every groundwater issue experienced!**

1. Reduce nitrate causing uses.
2. Septic system inspections.
3. Changes in land use practices. There are several winter agricultural cover crop initiatives going on in the Town of Wheaton and Chippewa County.
4. Using bottled water.
5. Installing reverse osmosis system.
6. Installing a new well. We strongly urge residents to reach out to Chippewa County Land Conservation and Forest Management and U.W. Stevens Point Central Wisconsin Groundwater Center for assistance before proceeding forward with this option.

Chippewa County Land Conservation and Forest Management (LCFM) formed an AD HOC Well Program Committee which is led by Lynda Schweikert, Dept. Chair of LCFM. The money comes from the American Rescue Plan Act (ARPA) funds from the Federal Government.

Supervisors Alice Droske and Carolyn Kaiser represent Wheaton on this committee. Other members include representatives from the U.W. Stevens Point (Groundwater Education Specialist), environmental engineers, DNR, Geologists, and Chippewa County Public Health.

Committee meetings are held at the County courthouse and open to the public. At the time of this writing, the Town of Wheaton has received maps in regards to water flow, areas of the township where wells have been tested and levels of nitrates in varying areas. There are numerous causes of why your nitrate level may be high. The key point is, we want everyone to be healthy.

Be watchful for visuals as maps will be posted, watch the Town of Wheaton website, come to a town board meeting with questions, get your water tested, and/or attend an AD HOC Committee meeting at the Chippewa County Courthouse.

There are two local companies that will do nitrate testing for free, and there may be others. Gibson Water Care and Culligan's also have technicians that can guide you with options available, if you choose, such as reverse osmosis.

DOG LICENSE INFORMATION: (See Real Estate Tax info below for further info)

Per Wisconsin Statute, all of your dogs over five months of age must be licensed. The annual fee for licensing is as follows:

- Spayed or neutered dogs - **\$8.00**
- Unspayed or unneutered dogs - **\$13.00**
- Multiple dogs for up to 12 tags - **\$60.00**
- Each additional tag for multiple dogs in excess of 12 -**\$7.00**

PROOF OF CURRENT RABIES VACCINATION IS REQUIRED. WITHOUT PROOF OF RABIES VACCINATION, A LICENSE WILL NOT BE ISSUED.

PENALTIES

You will be charged a minimum late fee of \$25.00 for each dog five months of age or over who is unlicensed by April 1st of each year, or within 30 days of acquiring ownership on or before the dog reaches licensable age. If you fail to have your dog vaccinated against rabies as required by statute, you may be required to forfeit not less than \$50.00 or more than \$100.00.

THE WISCONSIN STATE STATUTES REGARDING THE RESPONSIBILITIES OF DOG OWNERSHIP IS AS FOLLOWS:

- (1.) Dogs more than 5 months of age shall be licensed by April 1 of each year or within 30 days of ownership of a dog 5 months of age or older, or a late fee of \$25.00 shall be imposed.
- (2.) Proof of rabies vaccination is required before a license will be issued.
- (3.) Dogs are not allowed to run at large. All dogs must be kept on the owner's premises and under the control of the owner or some other person.
- (4.) Dogs running at large are subject to impoundment.
- (5.) If the owner permits a dog to run at large, the owner shall forfeit not less than \$25.00 or more than \$100.00 for the first offense and not less than \$50.00 nor more than \$200.00 for subsequent offenses.

(6.) The dog owner can be held liable for a dog causing injury to a person, domestic animal, or property. The penalties imposed can be from \$50.00 to \$500.00, depending on the circumstances. The penalties are in addition to any other liability imposed on the owner of the dog.

If you are a landowner and have tenants who are dog owners, please forward this information to them. Thank you.

REAL ESTATE TAX INFORMATION FOR 2023 - 2024

As a friendly reminder, when you receive the Real Estate Tax Statement, the check for the first half or full payment of your real estate taxes must be made payable to: **TOWN OF WHEATON TREASURER**, on or before January 31, 2024. A January 31, 2024, postmark will be accepted. Please include your phone number on the check. This is important so that we can contact you if there are any questions about your payment. Without your phone number, the tax payment may be delayed.

Submitting your payment(s) is as easy as 1, 2, or 3.

1. Drop your payment(s) in the secure drop-box at the Town Hall. It is located just to the left of the town hall entrance.
2. Drop your payment(s) at the Town Hall during in-person treasurer hours on:

Please do NOT mail the first half or full payment property tax payment to the Chippewa County Treasurer **BEFORE** the January 31, 2024 date. Should this happen, the Chippewa County Treasurer’s office then has to mail your payment back to the Town of Wheaton Treasurer for processing.

The second payment, if there is a second payment; the County Treasurer will mail you a tax statement regarding the remaining amount owed, which needs to be paid on or before July 31, 2024. Please make the second payment check payable to:

HAZARDOUS MATERIALS

Hazardous Materials (includes Paint, Light Bulbs, and Chemicals of all kinds) are NOT accepted. Residents must save hazardous materials and take them to Chippewa County Clean Sweep held in the Spring and Fall or take them to an area business that will recycle them properly.

Electronics (includes TVs, Computers, VCRs, Printers, and Monitors) are NOT accepted. Residents can take them to First Choice at 525 Park Ridge Drive Suite 1 Eau Claire, WI 54703. Phone number is 715-833-2005.

TOWN PARK

The Wheaton Town Park is your one stop for Winter fun! From sledding to ice skating to snowshoeing to snowmobile trail access. It is located at 3900 38th Street, Elk Mound. A second park entrance is located right across the street from 3601 40th Street, Elk Mound. Improvements continue to be made as volunteers and funding becomes available. In 2023 the following improvement projects were completed at the park:

- For Earth and Arbor Day this year a collaborative project between Elk Mound School District 4th Grade classes, Parks Commission, Plan Commission, and Department of Natural Resources brought 100+ new pine trees to the 40th Street field. Students were able to learn about trees, planting techniques, mulching, and caring for trees after being planted.

- A new trail was added to the trail system called Outfield Pass that connects the bottom of the sledding hill/Mounder trail to Oak Knoll field/gravel parking lot.
- Donations were received for bench and tree additions. A bench was placed by the Pine Grove Loop trail overlooking the original park. A second bench was placed on the trail system along the Town Corridor trail. Trees will be planted in the spring.
- This year we were fortunate to receive 2 boy scout eagle projects and 1 girl scout take action project in the park. These scouts must raise 100% of the project funds through their own fundraising efforts and any project funds left over are given to the Town of Wheaton to offset future maintenance costs.
 - BSA Troop 71 Elk Mound
 - Grady Larson’s Eagle Scout Project was a sled borrowing station and bench at the sledding hill.
 - Shawn Pinder’s Eagle Scout Project was a Little Free Library "Take a Book. Share a Book." It really is that easy:
 1. “Take a Book” for reading in the park or other places. Anyone may take a book – neighbors, park visitors, even passersby – the books are always free!
 2. “Share a Book” for others in the Little Free Library. Book donations are welcome at this Little Free Library!

This new park feature will be available year-round as the little free library is located next to the tennis court parking lot by the trail map. This parking lot is plowed during the winter season. To learn more visit <https://littlefreelibrary.org/map/>

- Girl Scout Troop 3365 Elk Mound
 - Ella Books and Evelyn Sarbeck’s Take Action Project was adding a bench to the ice-skating rink for adults to enjoy watching their kids ice skate and for trail users to have a spot to relax and enjoy Wheaton Park nature.

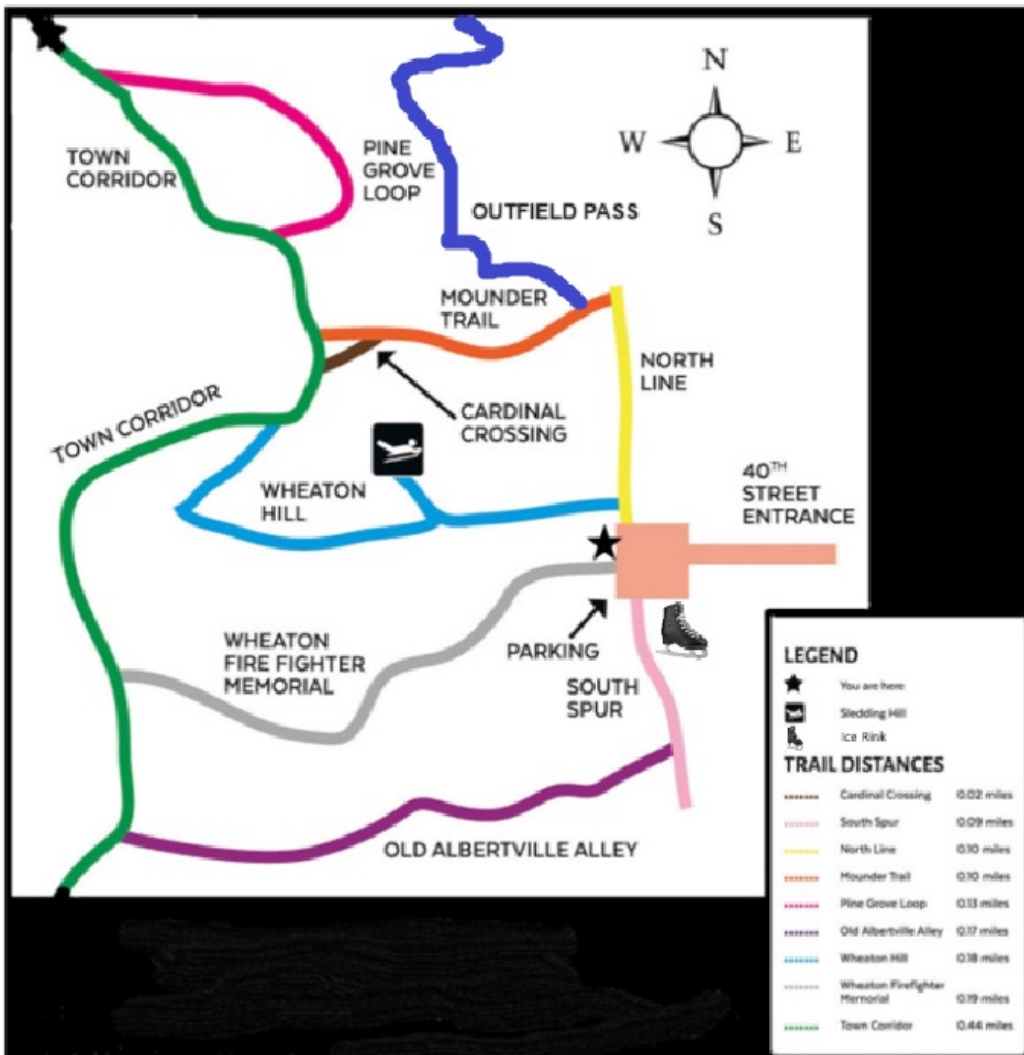

INTERESTING RECREATION TIDBITS

Did you know Wheaton Park has direct access to the Chippewa County snowmobile trail system along with parking for your truck and trailer? We absolutely do! Parking and snowmobile trail access is available at 40th Street park entrance. The snowmobile trail will run from the parking lot along the southernmost trail (Old Albertville Alley trail) and then connects to State Trail 33 or Wheaton Trail upon exiting the park property. Many thanks to the Wheaton Knight Riders for putting up and taking down snowmobile trail signage in the park!

PLEASE NOTE: Snowmobile trail no longer runs past the Wheaton Fire Station and crosses State Highway 29.

TOWN BOAT LANDING INTERESTING FACTOIDS

The Wheaton boat landing broke ground back in 1985 as a partnership project between the Town of Wheaton and Department of Natural Resources. The property was purchased from the Ralph Liddell farm. In the Wheaton archives we found Arley Engel President of Wheaton Parks and Planning Commission set out to make

Wheaton history by giving citizens public access to the Chippewa River right in the Town of Wheaton. Total project cost was \$6,145.00 which included 1000' x 20' roadway, 250' x 150' parking lot, 10' of cement planks, concrete approach, and labor. Funding for part of the project was through the County Conservation Aids program with Chippewa County being a sponsor. Mission accomplished Arley Engel and the other Wheaton Parks and Planning Commission members! Fast forward to 2023 and Wheaton boat landing with all the latest improvements is no doubt a definite gem of Chippewa River access.

TOWN BOAT LANDING

The Wheaton Town Boat Landing is located at 3001 106th Street, Chippewa Falls.

It has been a busy 2023 as major boat landing renovations to include boat launch replacement, new public dock, better handicap parking/accessibility, and security lighting were completed. There are no fees to use the new boat launch. Go check it out and watch for our ribbon cutting ceremony in 2024!

The Town of Wheaton was awarded by the Wisconsin Waterways Commission in August 2022 a Department of Natural Resources Recreational Boating Facilities (RBF) Grant for the maximum amount of 50% of the estimated project costs!



Reminder: For the safety of all park/boat landing users and pursuant to Wis. Stat. §167.30 – NO hunting is allowed on park and/or boat landing property.

WHEATON PARK ORNAMENTATION PROJECT CAMPAIGN

The Parks Commission has been adding amenities to the park over the last couple years and has also created an ornamentation project campaign for residents/non-residents. This fundraising campaign offers the community an opportunity to make a donation, memorial gift, or in honor gift with long lasting benefits to our area. By allowing for resident/non-resident and community donations this further creates a sense of community ownership to this project and unifies our commitment to the park.

Our project has 2 phases and to help keep Wheaton Park aesthetically pleasing we have selected the donation level options. Phase 1 focuses on areas around the lower pavilion and lower ball fields while Phase 2 focuses on areas around the upper pavilion and upper ball field.

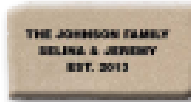
